Re: Freedom of Information Request – DES-FOI-2023-0007

Dear Mr Hamill

I refer to your request dated 12th February 2023 made under the Freedom of Information Act 2014, which was received on 13th February 2023 for records held by the Department of Education. Your request sought:

Access to all non-personal records within PDST relating to communications with the Le Chéile Schools Trust during the calendar year 2016. Specifically, this should involve searching the following two email accounts:

- ciaraodonnell@pdst.ie
- garycarley@pdst.ie

The search should seek all emails to and from the domain "@lecheiletrust.ie". Also specifically within the scope of this FoI request are all presentations, training materials, meeting minutes, communications or other records relating to the arrangement and delivery of an event at the Stillorgan Park Hotel on March 8th 2016. I'm interested in records relating to how the event was arranged, what content was requested, what content was delivered during the event, and what internal PDST considerations were made with respect what content should be delivered.

I, Brian Geraghty, Executive Officer, have now made a final decision in relation to your request on 10th March 2023.

Accordingly, the information is provided as follows:

Section 37 of the FOI Act recognises a very strong public interest in protecting privacy rights and this is reflected both in the language of section 37 and in the Long Title to the Act (which makes clear that the release of records under FOI must be consistent with "the right to privacy"). Privacy rights will therefore be set aside only where the public interest served by granting the request (and breaching those rights) is sufficiently strong to outweigh the public interest in protecting privacy.

Having carefully considered the public interest as it relates to disclosure of personal information, I have decided to partially grant your request. Some personal information has therefore been redacted from this record.

Section 15 (1) (a) of the FOI Act provides for the refusal of a request where the records sought do not exist or cannot be found after all reasonable steps to acertain their whereabouts has been taken.

In refusing your request I am satisfied that no such requested information exists.

Having carefully considered the interests of the body that supplied the information I have decided to refuse the records concerned as it contains information given in confidence.
